#### Private Heliskiing Package

The 'Private' Heliskiing Package is a 7 day heliskiing adventure comprised of 1 group of 4 people and up to 8 people with 2 guides. Our Private Heliskiing Package provides you with the exclusive use of one of our B2 Helicopters.

#### Private Heliskiing Package includes:

- Skeena Heliskiing provides you access to 9,250 square kilometers, the second largest skiable tenure in North America.
- Transportation to and from Smithers airport B.C., Canada. on Friday mornings. (Option to upgrade to helicopter transfer)
- Accommodation is double occupancy, with queen or king size beds all with en-suite. (Option to upgrade)
- All meals, snacks and non-alcoholic beverages.
- Full use of all Cliffs at Kispiox River Lodge facilities inc. whirlpool / hot tub, laundry facilities, games room, cross-country skis and snow shoes
- Internet
- Use of powder skis and poles, snowboards, safety ABS backpack including avalanche transceivers, shovel and probe.
- Provision of ACMG (Association of Canadian Mountain Guides), and/or UIAGM / IFMGA (International Federation of Mountain Guides Association) certified guides.
- Helicopter and avalanche Safety Training & Practice.

#### Please Note: Private Heliskiing Package does not Include:

- Your costs of travel to & from Smithers BC.
- Transfers outside of schedule pick-ups and drop-offs on Friday mornings. Extra transfers will be charged at \$340 per trip for a van shuttle.
- Travel & Cancellation insurance (please take out when you book your trip and ensure they cover heliskiing and ensure you understand the cancellation clause in the policy).
- Any Airport Taxes.
- Any alcoholic beverages at The Cliffs at Kispiox Bear Claw Lodge.
- Additional helicopter hours.

#### Registration and Payment

Payment of a non-refundable deposit of CAD \$ 8,000 together with the completed registration form is required to secure your booking. This deposit is taken off the total cost of your Exclusive Heliskiing Package.

Every client is required to sign a Release of Liability form before any heliskiing can commence. Please familiarize yourself with the sample waiver. If you require a waiver in any language apart from English, please let us know.

Payments can be paid by Cash, Cheque, Electronic Transfer, Direct Deposit or Credit Card.

Final payment is due 90 days prior to your Heliskiing Package commencement date. If final payment is not received on time we reserve the right to cancel the reservation without notice and your deposit is forfeited.

If registering later than 90 days prior to the package beginning date, the full Heliskiing Package price is due upon registration.

All prices are quoted in Canadian dollars and are subject to change without notice.

Additional friends can be added up to 4 weeks prior to package begin.

All clients must be paid for prior to package commencement.

#### Guaranteed Helicopter Time

Your Private Package includes 11 of helicopter flight time.

Costs for additional helicopter hours are charged at a rate of CAD \$ 2580 per helicopter hours flown over 11 hours.

#### Refunds

If the guarantee hours are not reached due to weather or mechanical problems you will be refunded CAD \$ 2580 per helicopter hour(s) not flown.

There are no refunds on helicopter hours if you choose not to fly during normal operating conditions.

#### Cancellation Policy

##### Cancellation by Client

The Private Heliskiing Package begins and ends on the specified dates and has been offered as a complete package. There are no refunds, total or partial for any unused services due to late arrival, early departure, sickness or accident.

Any cancellations must be made in writing and received via registered mail or fax 90 days prior to the arrival date of the Heliskiing Package to Skeena Heliskiing Inc. or to your booking agent.

In the event of cancellation by you, Skeena Heliskiing will retain the CAD \$8,000 non-refundable deposit. WILDERNESS ACTIVITIES

RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT (hereinafter the "Release Agreement")

BY SIGNING THIS RELEASE AGREEMENT, YOU WILL WAIVE OR GIVE UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE OR CLAIM COMPENSATION FOLLOWING AN ACCIDENT

DEFINITIONS

In this Release Agreement, the term "wilderness activities" shall include all activities, accommodation, transportation, events and services provided, arranged, organized, conducted, sponsored or authorized by the Releasees...

AVALANCHE AIRBAG SYSTEM

The Avalanche Airbag System ("AAS") consists of a backpack integrating an airbag system which is inflated by manually pulling an activation handle. Once inflated, an AAS may assist in keeping a person caught in an avalanche closer to the surface...

ASSUMPTION OF RISKS - AVALANCHES, ALPINE TERRAIN, WILDERNESS TRAVEL, WEATHER ETC. I am aware that wilderness activities involves risks, dangers and hazards. Avalanches occur frequently in the terrain used for wilderness activities...

I AM AWARE OF THE RISKS, DANGERS AND HAZARDS ASSOCIATED WITH WILDERNESS ACTIVITIES AND I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE OR LOSS RESULTING THEREFROM.

NOTICE TO SNOWBOARDERS AND TELEMAR SKIERS - INCREASED RISK

Unlike alpine ski boot/binding systems, snowboard and some telemark boot/binding systems are not designed or intended to release and will not release under normal circumstances. The use of a safety strap or retention device by snowboarders or telemark skiers without ski brakes will increase the risk of not surviving an avalanche.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of THE RELEASEES allowing me to participate in wilderness activities, I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against THE RELEASEES and TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury including death that I may suffer or that my next of kin may suffer as a result of my participation in wilderness activities...

- 2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any property damage or personal injury to any third party...
3. This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives...
4. This Release Agreement and any rights, duties and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of British Columbia...
5. Any litigation involving the parties to this Release Agreement shall be brought solely within the Province of British Columbia...

In entering into this Release Agreement I am not relying on any oral or written representations or statements made by the Releasees with respect to the safety of wilderness activities, other than what is set forth in this Release Agreement.

I CONFIRM THAT I HAVE READ AND UNDERSTOOD THIS RELEASE AGREEMENT PRIOR TO SIGNING IT, AND I AM AWARE THAT BY SIGNING THIS RELEASE AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES.
